Pre-Meeting Discussion	<p>Goodman - Goodman advised that this consultation meeting was to provide an update on the status of the project in accordance with the conditions of approval within the SSD consent. Jennifer voiced concern that RAPs invited to the update meeting were not being offered payment for attendance. Goodman advised this meeting is consistent with consultation with other stakeholders and interested parties who voluntarily attend meetings based on their interest in the project – including members of the community, neighbouring schools and aged care facilities. These stakeholders are not offered payment for their attendance.</p> <p>Jennifer Beale - Jennifer advised she would continue with the meeting but noted that the RAP she represents were not present at the test excavations and the RAPs who were present were not present at this update meeting even though they were invited.</p>

Oakdale West Estate - Overview	Stephanie Partridge – Provided overview of Oakdale West Estate, project description and planning approvals to date
Artefact – Works Completed to Date	<p>Ryan Taddeucci – Outlined works completed to date including the archaeological survey, AHIMS database search, test excavation program and the preparation of an ACHAR. Summarised the surface collection program and the proposed reburial program. Advised that artefacts and relevant documentation now ready to allow for the reburial to proceed.</p> <p>Kym Dracopoulos – advised he would make arrangements for the reburial pit to be dug to allow for the completion of the reburial.</p>
Site Works Update – Internal Infrastructure and WNSLR	Alasdair Cameron – Outlined site works completed to date and programmed for completion including internal infrastructure and the construction of the West North South Link Road (WNSLR)
Site Works Update – Lot 2B	Luke Ridley – provided an update on the construction of the warehouse on lot 2B including works currently underway and programmed activities
Unexpected Finds Protocol	<p>Kym Dracopoulos – Outlined the unexpected finds protocol in place on site and advised that the protocol is communicated to all workers as part of the site induction package.</p> <p>Jennifer Beale – is any training provided in identifying artefacts? Are Aboriginal people involved in identifying artefacts during works?</p>

	<p>Kym Dracopoulos – A common sense approach is implemented, any unusual finds (including bone or potential stone artefact) uncovered trigger the unexpected finds protocol.</p>
<p>Questions, Comments & Feedback</p>	<p>Jennifer Beale – Advised that unemployment levels of Aboriginal people from local communities is a major concern. Would like further information on whether Aboriginal people are employed as part of the earthworks and construction activities on the project and if so are they from local Aboriginal communities.</p> <p>Luke Ridley – Advised that Goodman will make enquiries with the three Contractors engaged to undertake the Oakdale West Estate works to obtain further information on Aboriginal employment on the project and will provide a response to Jennifer Beale, as Goodman do not employ any construction staff directly & have no transparency over information on the construction workers employed by the Contractors or their respected Subcontractors.</p> <p>The presentation and a copy of the minutes of this meeting will be distributed to all parties invited to today's meeting.</p>
